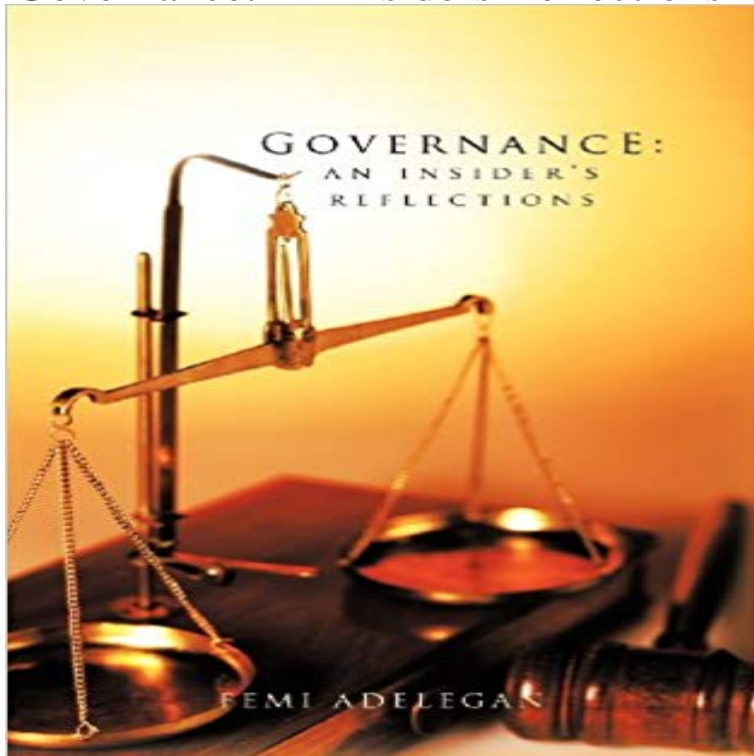


Governance: An Insiders Reflections
