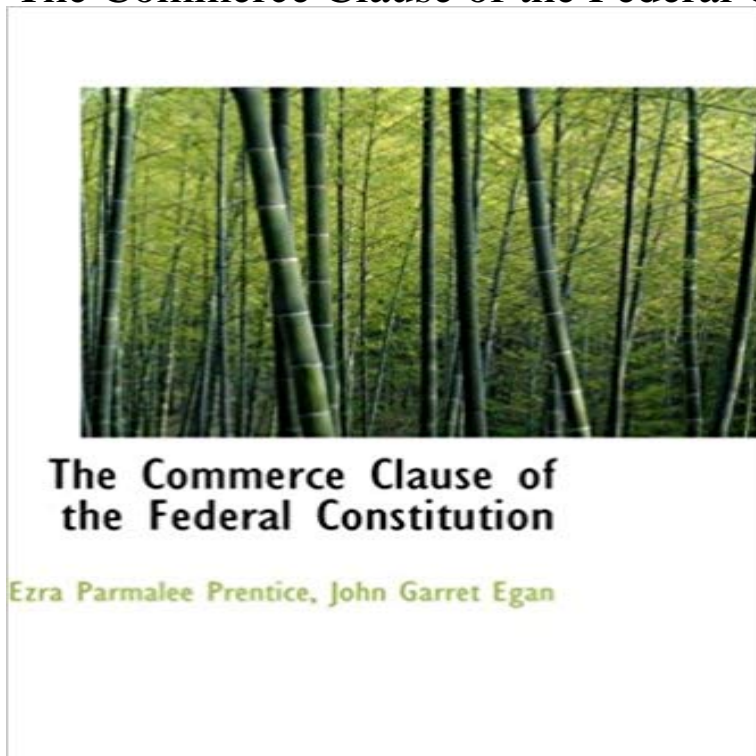


# The Commerce Clause of the Federal Constitution
